



COVID-19 Visitation Plan

Effective 26th June 2021 ongoing

In accordance with the latest information released 26th June in response to the increase in number of COVID-19 cases in New South Wales, the following will apply **until further advised**:

<p>Standard requirements for every person ENTERING the facility</p>	<p>All staff and visitors must wear a surgical mask while in a residential aged care facility.</p> <ul style="list-style-type: none"> • Must have current flu vaccination (children included) and provide proof of. (<i>Any persons older than 6 months of age are required to be vaccinated</i>). • Hand hygiene upon entry and exit • Maintain social distance with all staff, residents and other visitors. • Will not be able to enter if unwell • Please check in at the Admin window for screening. • Doors are currently locked and will be opened after window check. Please be patient as we stagger door openings in line with social distancing requirements at the sign in system.
<p>Sign in system</p>	<ul style="list-style-type: none"> • Each person entering facility to be signed in via electronic visitor system located at Reception. • Each visitor will be required to read the current hotspot/excluded locations list before signing in. • Mandatory health screening & temperature check • Visitor sticker label to be worn for duration of visit • Sign out via electronic visitor system located at Reception upon exit.
<p>Visiting times</p>	<ul style="list-style-type: none"> • 9:00am to 4:00pm Monday to Friday 9:00am to 1pm Saturdays • Closed Sundays and public holidays • No time set for length of stay • Pre-approved visits on compassionate grounds allowed outside visiting hours.
<p>Visitors</p>	<ul style="list-style-type: none"> • Maximum of 2 visitors per resident per day • Exclusions will apply to anyone who resides at, has travelled from, or been in contact with persons who has travelled from a currently listed hotspot. • Please refer to NSW Health website or phone our Admin team during visiting hours listed above to confirm.

	<ul style="list-style-type: none"> • If you are an out of area visitor, we recommend you phone ahead to confirm current restrictions/arrangements as it can change at very short notice.
Visiting locations	<ul style="list-style-type: none"> • Must occur in resident's room, not in social/ common areas and maintain social distancing at ALL times. •
Social outings	<ul style="list-style-type: none"> • Available Monday to Sundays pending any current advice/ restrictions as advised by NSW Health. • Risk assessment form to be completed and submitted for approval 24 hours prior to the outing. • Monday to Saturday doors open to come in and pick up resident. • Sunday/Public holidays: Doors closed. Buzz intercom at Admin entrance. Resident will be brought to meet you at main entrance • All events must be in accordance with with current social gathering government advice and recommendations • If a resident makes a decision to leave the facility to attend a family gathering or excursion does not need to complete a 14 day self-isolation upon return but this may change at short notice.
Verandah visits	<ul style="list-style-type: none"> • Still available for persons without a flu vaccination. • Monday to Saturdays within visiting hours. • Max 2 people.

Please be advised that these requirements can change at any time without prior notice in the event of transmission or outbreaks.

Any changes to visitation will be communicated as soon as new requirements are clarified. All information is based upon the current advice and recommendations from peak health and government bodies.
